## Development Planning in the National Planning Commission: An Insider View By Dr. Swoyambhu Man Amatya

Planning is recognized as an important tool and a process with which government agencies and others mobilize limited resources as efficiently and effectively as possible to the solution of high priority problems. Several periodic plans have been completed in Nepal since the introduction of first such plan in 1956. All these plans have tried to address the contemporary issues that would help alleviate poverty and enhance economic growth. Despite all these efforts, we have not been able to enhance economic growth or to minimize the poverty level. Blames are put, for instance in the case of agriculture sector, on lack of resources, inadequate irrigational facilities, less access to rural credit, high rates of investment, among others. Based on his experience as the Member–Secretary of National Planning Commission, Dr. Amatya's presentation will emphasize that we need to go beyond these simplistic explanations and reexamine the entire planning process before taking up something new.

Dr. Amatya, MSc (Oxford University), and PhD (Economics, Tribhuvan University), has served in the government bureaucracy in various capacities (including Secretary) for more than three decades. During his career he's been part of various Ministries and Commissions: National Planning Commission Secretariat, Ministry of Forests and Soil Conservation, Ministry of Environment, Science and Technology and Water and Energy Commission Secretariat. He was deeply involved in the preparation of the Three Year Interim Development Plan of Nepal (2007-2009). As focal point in policy co-ordination among line Ministries, he was instrumental in formulating and revising some of the existing policies of Nepal. He was the Chairperson for the Least Developed Countries and Landlocked Developing Countries' Conference held in Almaty, Kazakhstan, in 2007 and in Bangkok, Thailand in 2008. He has received various prizes and awards including Rastriya Pratibha Puraskar, King Birendra Science and Technology Academy Award, etc. His research articles have appeared both in National and International Journals. He is now Deputy Coordinator, International Union of Forestry Research Organizations (IUFRO), Vienna and Country Vice President, International Society of Tropical Foresters (ISTF).
