


Figure 1: SIAS Theory of Change





THEMATIC ACHIEVEMENTS

SUSTAINABLE NATURAL RESOURCES MANAGEMENT

SIAS has been making continuous efforts towards inclusive and climate adaptive natural resource governance through research, stakeholder engagement, local government partnership, publication and capacity building. SIAS in collaboration with local governments has piloted some nature-based solutions and institutional mechanisms for water management and taken useful insights from these endeavours to respective municipal policies. SIAS has carried out critical review of the ongoing policy reform on forestry and climate change and effectively coordinated 5 policy round tables to inform the on-going sectoral policy revisions such as forestry, environment, water, agriculture, climate change.

CLIMATE CHANGE AND DISASTER RISK MANAGEMENT

SIAS has been conducting research on understanding climate risk and addressing the vulnerability of local communities through ongoing and few new projects. SIAS has recently started a new project to explore ways of making urban planning and development resilient to multiple disasters by informing the current processes of urbanization and disaster risk management or mitigation. Through its research and local engagement, SIAS has been providing support to local governments to deal with climate related disaster risks.

WATER SECURITY AND URBAN RESILIENCE

SIAS has successfully accomplished a multi-year research on urban water security funded by IDRC, a Canadian research organization, and continuing its engagement with municipal actors towards informing their planning processes through the knowledge generated from action research. It has developed a tool called "Pani Chautari" (Water Forum) to foster local dialogue on urban resilience and water security. SIAS researchers have proactively articulated their evidenced-based understanding on issues of water security and urban resilience through publication and active engagement in policy processes.

DEMOCRATIC POLICY PROCESSES AND LOCAL GOVERNANCE

In the past few years, SIAS has expanded its work in the area of democratic policy processes and local governance. With the policy formulating process of government, SIAS has taken this opportunity to foster critical policy dialogues on the ongoing institution building at local level. Additionally, SIAS has engaged with both national and local level institutions to inform the policy processes. To increase state-citizen relations, additional interaction with parliamentarians has been prioritized to articulate citizen voice and interest group preferences in policies and laws.

ACADEMIC PUBLICATION

SIAS researchers have published their research findings in leading international journals. A total of 15 peer reviewed journal articles have been published this year. Likewise, SIAS researchers have also published and contributed as co-authors to a number of book chapters, published five policy briefs, presented a total of 14 conference papers at National and International conferences. In 2018, a special issue of New Angle has been published on *Water security, governance and justice in the Himalaya under a changing climate*.

MEDIA COVERAGE

Events and activities of SIAS have been featured in broadsheet national dailies, online news portals, televisions, and radios this year. Additionally, SIAS researchers have written a total of 10 media articles and blogs as an attempt to create a public discourse on the issues of natural resource governance, water management, local governance, climate change, disaster management and policy reform.

HOSTING CONFERENCE

Third Public Policy and Governance Conference

This year, SIAS jointly hosted the 3rd Public Policy and Governance, a South Asia level conference held in Kathmandu with the conference theme of "Expanding Public Choice and Market Opportunities" with Nepal Administrative Staff College (NASC) and other collaborators. More than 300 scholars, academics, and practitioners from South Asia in the field of public policy and governance participated in the conference. SIAS has also taken the lead role in documenting the proceedings of the conference. To advance the discourse on its thematic working area, SIAS contributed as a presenter, panelist and delegate in various national and international seminars and conferences.

Local Water Conference

SIAS hosted national level Local Water Conference in Dhulikhel in collaboration with Municipality Association of Nepal (MuAN), Dhulikhel Municipality, ISET-N and LiBird . This conference was an encounter of local government officials, researchers, policy makers and academia and provided a platform for discussion on water related issues faced at local level. There is a firm commitment from the organizations to carry on the conference of these level.

CAPACITY BUILDING

SIAS is continuing its effort to build research capacity of its members. During this year, writing workshops and seminars for SIAS researchers were held. For instance, to provide conceptual clarity and to develop researchers' skill in policy brief writing, a seminar on policy writing was organized in 2018. SIAS also hosted a field course on environment and development with the University of Edinburgh where four Nepali students got the opportunity to participate.





ORGANIZATIONAL DEVELOPMENT

INSTITUTION BUILDING

To provide strategic direction of the organization's initiatives, SIAS has finalized its strategic plan (2019 – 2021). SIAS has adopted a policy of systematic documentation of achievements and lessons through publishing annual report. SIAS has also endorsed its publication and authorship policy.





PARTNERSHIP AND FUNDING DIVERSITY

This year, SIAS has been able to diversify its funding sources and partnership. SIAS has entered into the Memorandum of Understandings (MoU) with the University of Edinburgh and started collaboration through a multiyear research project and field courses. SIAS has intensified collaboration with existing partners such as Swedish University of Agricultural Sciences (SLU) with three new projects and exploring new collaboration with Chinese Universities. SIAS is seriously mulling over more substantive collaboration with local institutions such as Federation of Drinking Water and Sanitation Users Nepal (FEDWASUN), MuAN and national research institutes namely National Democratic Institute (NDI), Niti Foundation among others for research and policy engagements. List of partners and collaborators from local through international levels is provided in Annex 4.





OTHER INITIATIVES

POLICY LAB

Policy Lab is a unique approach to critically discuss on policy making that involves the use of new policy tools and techniques. It aims at improving policy initiatives by fostering research-community partnerships. SIAS has hosted two Himalayan Policy Lab (HPL) so far aiming to facilitate critical discussions on question of knowledge politics in the Himalaya, and to produce alternative forms of knowledge, which, subsequently, increase the possibility of transcending the worlds of academics, policy and practice.

FUTURE HIMALAYAN RESEARCH SEMINAR SERIES

SIAS has conducted three seminars under the Future Himalayan Research Seminar Series inviting national and international experts to contribute towards fostering critical analytical skills and knowledge development of researchers.


NEPAL POLICY RESEARCH NETWORK (NPRN)
