

The year 2023 has yet been another successful year for SIAS towards achieving its goal of being recognised as an established think tank and becoming a 'Centre of Excellence'. As we head into the next fiscal year, I feel extremely delighted to share our annual report for the year 2022/23. This annual report highlights our achievements, working approach, activities, engagements and lessons during the period. We continued to focus our research on thematic areas such as sustainable natural resources management, climate change and disaster risk management, water security and urban resilience and local governance and policy processes. We also made remarkable progress in terms of delivering high quality knowledge outputs which not only contributed to the international scholarship but also provided important evidence and lessons for national and regional level policies. This year also, we continued Future Himalaya Seminar series and were successful in organizing half a dozen of seminars covering the diverse issues. We also organized different internal capacity building training and workshops such as advanced scientific writing workshop series and module for blog writing. Furthermore, we have strengthened our policy engagements through number of policy dialogues with diversified collaborator on issues related to water, climate change and wildlife.

Southasia Institute of Advanced Studies (SIAS) is a Kathmandu-based policy research institute striving to become a 'Centre of Excellence' in policy research in South Asia. It was established in 2011 for undertaking research, policy engagement, and scholarly exchange across South Asia and beyond. SIAS operates in a research-policy-practice interface, which accommodates multiple themes of sustainable natural resource management; climate change, water, urban resilience; rural livelihoods and ecosystem services; democratic processes and local governance. It aims to utilise its research to create state-of-the-art knowledge to understand, engage and inform public policy processes and contribute to sustainable development in the South Asia region.



SIAS is a not-for-profit research institution registered under the Company Act of Nepal. It enjoys rights conferred under the Company Act and other applicable laws and will uphold constitution and relevant laws of other countries while undertaking its engagements outside Nepal.



SIAS is governed by a Board of Directors (BoD) elected by the General Assembly. The board comprises of a group of professionals committed to deliver high quality research and engage in policy processes. For internal management, there is a Management Committee (MC) chaired by the Executive Director. This committee is accountable to the Board of Directors.







Vision

SIAS envisions becoming a research institution that supports evidenceinformed policy and practice towards inclusive and sustainable development. It works to realise this vision of getting recognised in Nepal, South Asia and around the globe as a unique South-based high quality policy research organisation, with a reputation as a policy think tank.

Mission

SIAS's mission is to nurture, cultivate, organise and promote critical knowledge, research and scholarly learning in South Asia. It focuses its research in Nepal and South Asia (and beyond) through building regional collaborations in carrying out research and contribute to evidence informed policy process.

Objectives

- Conduct high-quality research and analysis and generate action-verified lessons and the state-of-the-art knowledge on environmental, socio-economic and political issues.
- Critically engage in the policy process from national to local levels.
- Build and enhance capacities of research community and professionals.
- Inform practitioners, policy makers and epistemic communities (researchers and academia) with evidences and rigorous analysis to support research informed policy decisions.





Figure 1. SIAS theory of change

SIAS has adopted the theory of change as its organizational development framework (Figure 1). The theory of change describes how it contributes to realizing its vision of evidenceinformed policy and practice towards inclusive and sustainable development. As illustrated, SIAS invests in research interventions and policy analysis that leads to achieving desired outcomes, informing its target audience and contributing to achieving its vision. It works across four central thematic areas: i. Sustainable natural resource management ii. Climate change and disaster risk management, iii. Water security and urban resilience, iv. Local governance and policy process; and Gender and social inclusion and public policy processes are the cross-cutting themes (Figure-1 themes). SIAS strives to generate critical knowledge and evidence (Figure 1- outcomes) to inform, empower and capacitate policymakers, practitioners and epistemic communities (Figure 1- target audience) through research and innovation, policy engagement, capacity development and research communication (Figure 1- approaches). It strategizes policies and actions to foster evidence-informed policy and practices through engagement with the epistemic community, the policy community, the local community, and practitioners. In doing so, it adopts four interconnected approaches of research and innovations, critical policy engagement, capacity building (of researchers and stakeholders), and communication and dissemination.

Sustainable Natural Resource Management


SIAS has been continuously engaging in policy research related to agriculture, forest, land, and rural livelihoods focusing on smallholder farming, forest management and governance, and agro-forestry-based enterprises. This year also, SIAS conducted multiple research projects that have explored different aspects of natural resources management in the face of changing socio-economic context of Nepal and the Southasia region. These research and policy engagements helped SIAS continue to document the changing relationship of people with natural resources in the context of high rural migration, changing livelihoods and post COVID-19 challenges. To complement this approach, SIAS has started a new action research project that aims to investigate wildlife encroachments as an unintended negative consequence of forest restoration and explored some of the potential policy responses to address the problem faced by smallholder farmers in the Himalaya. Additionally, we are also studying the roles of local institutions in forest restoration and reflect on impacts global environmental priorities and differential implications at the local level. Adopting political ecological and intersectional lens, SIAS is unpacking different constraints that create barriers to sustainable and equitable resource governance and women's economic empowerment. Likewise, recognising the importance of an integrated approach for sustainable resource management, SIAS continues its efforts to comprehend the interlinked drivers and processes of landscape and watershed degradation.

SIAS organised local, provincial, and national level workshops and policy dialogues in order to strengthen its engagement with the local people and stakeholders and foster policy-research linkages. These dialogues focused on topics such as institutional and productive functionality of community forestry, agri-business enterprises, water management and collective efforts for sustainable and equitable natural resources governance. SIAS is credited for co-producing local resource-based economic opportunities for rural women and driving policyrelevant research on the issues of forest (wintergreen promotion and reflection on silviculture-based management) and water management.

Climate Change and Disaster Risk Management

SIAS has been engaging in research-policy-practice domain that help foster science and public policy linkages on climate change and disaster-related issues. Often these aspects are integrated as the cross-cutting issues in our research and analyses, particularly in water and agriculture that affect the lives and livelihood of millions of people in the region. One of the notable initiatives SIAS has embarked on is a long-term research project that focuses on migration as a strategy to adapt to climate change. The research aims to analyse how climate change influences migration dynamics and intersects with other underlying drivers that increases migration. We have also promoted national and local level dialogues on the challenges of climate change to share research findings that help create opportunities to foster science-policy linkage. We have published a special issue of the New Angle: Nepal Journal of Social Science and Public Policy on 'Urbanisation and Disaster Risks in the Himalaya', Volume 7 (1), 2021, which analyses disaster risk production and management in the context of rapid but haphazard urbanisation in the Himalayan region.

Giving continuity to co-produce an analytical tool for identifying the root causes of multi-hazard risks with the active participation of local communities, local governments, and national-level stakeholders, SIAS has expanded its work in the Western Nepal. While developing visions of tomorrow's cities, we formed disaggregated groups including women, youth and socio-economically poor members of the community and documented their visions for the future development of a risk-sensitive land use plan. In our urban and disaster risk research, we have profoundly recognised gender as one of the key themes. Our analyses delve into the vulnerabilities and capabilities of women and marginalised urban inhabitants, incorporating the intersections of various identities.





Water Security and Urban Resilience

SIAS continued to remain at the forefront of research and analysis that support strengthening local water governance, ensuring water security, and addressing gender and social injustices in access to water and water-related decision-making. With over a decade of engagement in water research focusing on issues relevant to sustainable water management, equity and justice issues and climate-induced risks on water systems, SIAS has contributed to evidence-informed policy and practices that help bridging the knowledge gaps between the communities and local governments. SIAS has also been prominent in knowledge exchange through national-level policy dialogues, and participation and contribution in national, regional and international-level water policy labs, seminars, conferences, and scientific publications. More recently, we have also initiated research communication through research materials in vernacular languages such as blogs focusing on mid-hills springs and videos documenting the evidence. We have also adopted a participatory approach in appraising the status of water resources within our study areas.

SIAS has continued to explore urban marginalisation issues. Documenting local knowledge, perspectives and visions and strategically amplifying their agency, SIAS is uncovering the issues of urban marginalisation and focusing on the development of political capabilities of the marginalised people, strengthening the voice of poor, women and marginalised people in the urban planning. Besides, our research engagements and approaches are centered around the gendered politics of water governance. We unravel complex gendered experiences of water management, which are further compounded by the intersections of gender, caste and class and other social divisions. Our aim is to uncover the experiences and perspectives of the marginalised communities around drinking water distribution, source management and related decision-making processes.

Local Governance and Policy Processes

We have been focusing on research and policy engagement to understand the challenges faced by the local governments in delivering the state-services, policy making and mobilising the resources as provisioned in the constitution. This has helped us to highlight the opportunities and constraints that the local governments encounter in managing resources across various sectors and fulfilling their mandated roles. Our primary objective is influencing the local and national policy processes by leveraging research findings, engaging in stakeholder dialogues, and sharing knowledge across sectors, including water, climate, forest and disaster management. We work closely in collaboration with local governments and communities to strengthen their capacities in designing, piloting, and encouraging the adoption of nature-based activities that help in sustainable environmental management and improved food, water, and livelihood security.

We have organised focused-dialogues on wildlife risks bringing together the relevant stakeholders in a common forum. Engaging with diverse stakeholders- including indigenous inhabitants, local women farmers and local government officials- in deliberative forums, we focused on discussions that contribute to devising solutions related to environment and climate change, natural resources management, urban and disaster resilience, women's economic empowerment and inclusive local governance. SIAS ensured that these engagements were inclusive with active participation of women and marginalised communities and the research team members constantly encouraged and facilitated them to voice their key concerns. SIAS has continued policy analysis identifying the policy gaps in gender and social inclusion, incoherence in sectoral policies as well as challenges in policy translation.






Academic and Policy Relevant Publications

SIAS researchers have been publishing their work in leading international journals. A total of five peer-reviewed journal articles have been published this year. In addition, we have published four articles on a special issue of New Angle on 'Urbanisation and Disaster Risks in the Himalaya', Volume 7 (1). The issue is available in hardcopies and are also publicly accessible in SIAS website. The issue was distributed in different local, national and international events.





Similarly, one article has been published on a special issue of New Angle on 'Understanding the Changing Livelihoods, Vulnerability, and COVID-19 Pandemic', Volume 8 (1), 2022. A special issue on "Women's empowerment in natural resources management in the Himalayas", Volume 9 (1), 2023 is underway with authors working on their manuscripts.









Media Coverage

Like in the previous years, activities and events of SIAS have been featured in national dailies and also widely reported in the online news portal. The national and local level events of Tomorrow Cities project have been featured in renowned online media house in Nepal, including *Online Khabar* and other media outlets like *Artha Dabali, Capital Dainik, Sabdapati*, etc. Likewise, our action research on Wintergreen plantation in the Community Forest (CF) of Dolakha and *Rajma* branding have been highlighted by local media.

This year, SIAS researchers published a total of six blogs/Op-ed (5 English and 1 Nepali). These blogs/Op-eds drew on the findings, insights and experiences of the researchers on local water management policies and practices, causes of urban disasters, implications of emotional reflections while performing qualitative research, and implications of COVID-pandemic in agribusiness of smallholder farmers of Nepal.









As in the past years, this year also, SIAS organised various capacity building events and continued its efforts to enhance the research skills of emerging researchers, including its staff, interns, partners and collaborators. A novel co-learning platform 'Research Clubs' has been initiated for nurturing the emerging researchers in SIAS and beyond. A total of four Research Clubs, organised this year, facilitated the researchers' ideas and findings of their working papers and theses. As a part of fostering the analytical and reflective writing, SIAS organised two blog writing workshops. Committed to elevate the effectiveness of its capacity enhancement activities, SIAS invited a recognised external resource person who acquainted the participants with invaluable tips on blog writing and provided feedback on the blogs they drafted. Likewise, SIAS also organised a number of capacity building workshops on career development and mentoring to guide the researcher in conducting and analysing research and writing. Integrating capacity building activities in research projects, SIAS has been working closely with the field officers and the project team members and organising training and capacity building workshops to enhance their research skills. Through the Future Himalaya Research Seminar series (as explained in detail below), SIAS continued to offer in-house and external researchers a platform to share their finding, experiences and insights from their ongoing and completed research works.

Institutional Building

SIAS undertook some organisational development initiatives and worked with universities and a range of other national and international research organisations to implement new research projects and expanded its networks and partnership in the region and beyond. In addition, SIAS organised several research and policy events virtually and in-person. Like in the past, SIAS publishes its annual report this year to systematically document the achievements and lessons learnt. We are committed to promote gender and social workforce diversity. SIAS and our team sensitises and promotes Gender Equality and Social Inclusion (GESI) approaches in office as well as during the field activities. SIAS has recruited additional staff for different research projects and administrative work this year. Some of the SIAS researchers have been competitively selected for the higher studies in renowned universities with full scholarships this year as well. For instance, Ms. Avipsha got enrolled in a fully funded Master's program at Asian Institute of Technology. Likewise, Ms. Supriya Lama got funding for Master's program at University of New South Wales and Ms. Monika Giri was awarded fully funded Ph.D. position at University of Georgia. Binod Adhikari started his PhD through a joint project between SIAS and the Swedish University of Agricultural Sciences (SLU). They will be SIAS's partners, collaborators or researchers in the future.

Partnership and Funding Diversity

SIAS has put in a great deal of efforts to broaden its partnership and diversify its funding sources this year. It has continuously strengthened its prior partnership and networking with existing research organisations and applied for different research grants in collaboration with both existing and new partners in Nepal and beyond. With some recently initiated new projects, our research partnerships with national research institutes and local governments have been further expanded. In addition to the longstanding focus in qualitative research, SIAS has been engaging into large-scale quantitative research projects. Our focus and commitments in quantitative research have contributed to expand our research portfolio as an institution with expertise in both qualitative and quantitative research. SIAS's expertise in qualitative and quantitative research has generated opportunities to build networks with diverse stakeholders in the field of natural resources management (land, water, forestry, and agriculture). Through the Tomorrow's Cities project, we have also been conducting multidisciplinary action-research that helped foster collaboration among physical scientists (geologists, earthquake, landslides and floods experts), urban planners and architects (engineers) and human geographers. A list of partners and collaborators of SIAS has been provided in Annex 3.



Policy Perspectives in South Asia



In line with its regional engagement strategy, SIAS has been carrying out critical reviews of national water policy documents, engaging in regional dialogues and reflecting on the policy-practice interface in partnership with the Institute for Study and Development Worldwide (IFSD) based in Australia.

Himalayan Policy Lab

Considering the Himalayan fragility in terms of geography as well as being a socially deprived region, the Himalaya Policy Lab engages in an agenda of transformation of Himalayan socio-ecological systems to encompass socio-environmental justice. This Policy Lab is a unique approach that facilitate evidence informed policy dialogue where policy stakeholders engage with the researchers and utilise research findings to find policy solutions. It aims at improving policy initiatives by fostering research (epistemic)-community partnerships. SIAS in collaboration with renowned research organisations, such as IFSD will keep on organising future Himalayan Policy Labs.



Future Himalayan Research Seminar Series



SIAS introduced Future Himalayan Research Seminar Series which has been recognised as a platform that cultivates the culture of scholarly exchange and shared learning. It provides opportunities to the national and international researchers and experts to present their research and benefit from the feedback of the participants of the series. Every year SIAS invites experts to contribute towards fostering their critical analytical skills and knowledge development. Besides, presenting the research findings and receiving feedback, the seminar also contributes to build social and intellectual relationship with contemporaries and experts from diverse array of research tradition within the overarching themes. This year, we organised six such seminar series which were delivered by international academicians and practitioners working across the world. The seminars were conducted in the hybrid modality i.e., both online and in person. This year, the seminars focused on various aspects of sustainable and inclusive resource management, including changing socio-economic conditions of Nepal triggered by out-migration and COVID-19 pandemic. The series fostered discussions on various aspects of community conservation, forest restoration in the context of global climate goals, contribution of buffer zone program in improving the park-people relationship and overview of food system in Nepal.


