It is my immense pleasure to present the Annual Report of the Southasia Institute of Advanced Studies (SIAS) for the year 2024/25. This year has been a period of continued growth, learning, and deepened engagement for SIAS as we further strengthened our position as a leading policy research institute in Nepal and the South Asian region. Our work has remained grounded in the commitment to bridge research, policy, and practice ensuring that knowledge production directly contributes to inclusive, equitable, and sustainable development outcomes.

Throughout the year, SIAS has continued to advance its mission through diverse research, outreach and policy engagement activities such as dialogues. A total of 12 projects were implemented, contributing to knowledge generation and evidence-informed policy discussions. We organized eight major policy and research-related events, including workshops at various levels. SIAS researchers participated in 14 international forums, strengthening our international engagement and collaborations. In terms of publications, SIAS released Volume 9 of the New Angle Journal, alongside five peer-reviewed articles in international journals, 15 op-eds/blogs, two policy briefs, and one booklet.

We have focused on advancing discourses that address pressing development challenges. Through consultations, dialogues, and collaborative initiatives, SIAS has helped generate actionable insights and policy-relevant recommendations. Similarly, SIAS continued to strengthen its role as a knowledge hub by fostering critical exchange and dialogues among researchers and policy makers and practitioners and capacity building.

Our outreach extended beyond borders, reflecting SIAS's growing presence in regional and global conversations while remaining deeply grounded in local contexts. Collaborative engagements, knowledge-sharing activities, and partnerships have reinforced our role in connecting diverse perspectives towards advancing inclusive approaches to research and development. Capacity building remained a cornerstone of our work, with initiatives designed to support emerging scholars, promote experiential learning, and encourage cross-cultural exchange. These efforts not only strengthened individual skills but also contributed to building a wider network of engaged and informed professionals committed to addressing contemporary challenges. None of these achievements would have been possible without the dedication of our researchers, the guidance of our Board, the support of our partners, and the trust of the communities we work with. We extend our sincere gratitude to all who have contributed to our journey.

1. ABOUT SIAS



Southasia Institute of Advanced Studies (SIAS) is a Kathmandu-based research institute committed to becoming a 'Centre of Excellence' in policy research across South Asia. Founded in 2011, SIAS provides a platform for research, policy engagement, and scholarly exchange across South Asia and beyond. With a focus on the research-policy-practice interface, SIAS undertakes impactful studies and advances evidence-based policy solutions for addressing societal challenges, including natural resource management; climate change; water security, urbanisation; disaster risk management; rural livelihoods; ecosystem services and local governance. Its mission is to generate cutting-edge knowledge that informs and shapes public policy, strengthen the capacity of researchers, policymakers, and professionals, and foster sustainable development across South Asia. SIAS collaborates closely with research institutions and partners across South Asia, Europe, the Americas, and Australia.



1.1. Legal Status

SIAS is a not-for-profit institute registered under the Company Act of Nepal. It operates under the rights conferred by the Company Act and other applicable laws and will uphold to relevant regulations of other countries while undertaking its engagements outside Nepal.



1.2. Vision

SIAS envisions establishing itself as a leading think tank that supports evidence-informed policy and practices, fostering inclusive and sustainable development. It is dedicated to achieving this vision and gaining regional and global recognition as a unique, high-quality policy research organisation, based in the Global South.



1.3. Mission

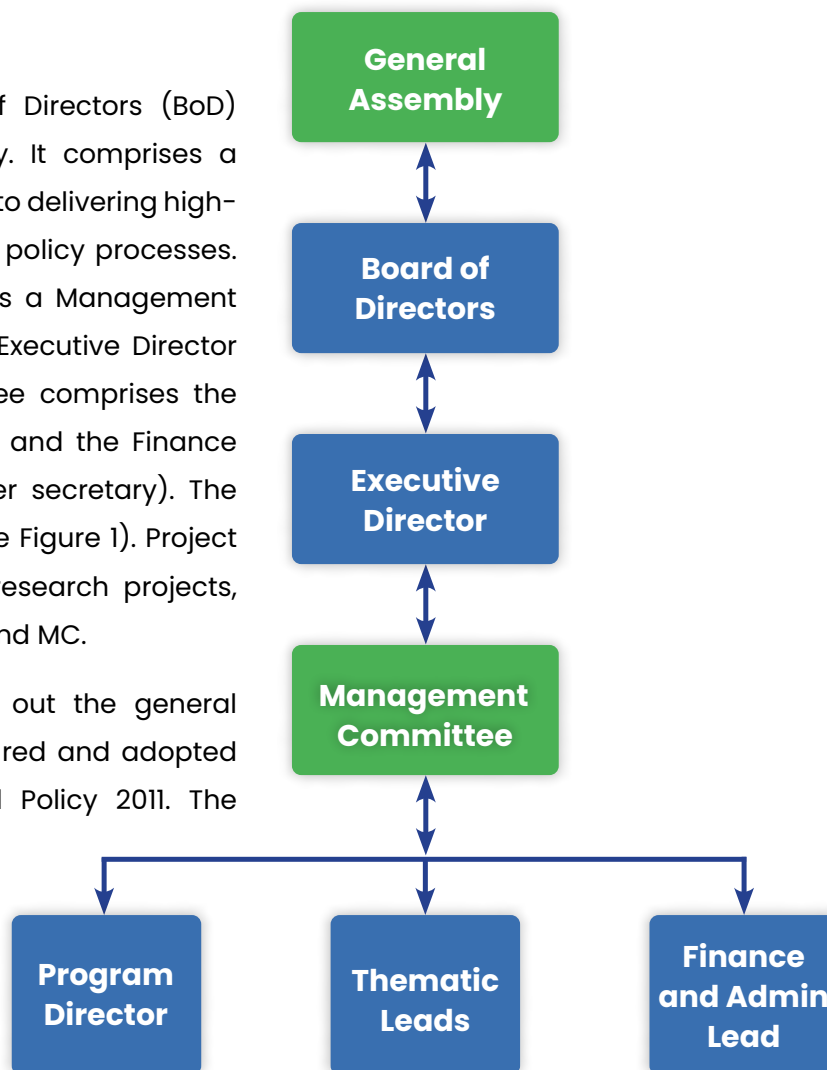
SIAS's mission is to nurture, develop, organise and advance critical knowledge, research and scholarly learning across South Asia. Based in Kathmandu, it currently focuses its activities in Nepal, with collaborations expanded to India and Bhutan. In recent years, SIAS has also initiated collaboration with Bangladesh, and intends to expand its geographical coverage in the region.

1.4. Governance

SIAS is governed by a Board of Directors (BoD) elected by its General Assembly. It comprises a group of professionals committed to delivering high-quality research and engaging in policy processes. For internal management, there is a Management Committee (MC) chaired by the Executive Director (ED). The management committee comprises the Program Director, thematic leads and the Finance and Administration lead (member secretary). The MC is accountable to the BoD (see Figure 1). Project leaders are authorised to drive research projects, with strategic inputs from the ED and MC.

The SIAS Board of Directors set out the general strategic direction and has prepared and adopted the Administrative and Financial Policy 2011. The policy provides guidelines for the operation of SIAS finances, including the creation and maintenance of its accounts, handling of expenses and reimbursement, handling the

petty cash, procurement, financial reporting, fund mobilisation, bank account, and audit. SIAS has also endorsed its Human Research Ethics Policy 2016, Publication and Authorship Policy 2018, and Gender Equality and Social Inclusion Policy 2022 to ensure an inclusive research process and deliver high-quality outcomes.



1.5. Objectives

- Conduct cutting-edge research and analysis and generate action-verified lessons and state-of-the-art knowledge on environmental, socio-economic, and political issues.
- Engage critically and constructively in the policy process at local, national, and regional levels.
- Develop the capacity of the research community and professionals and engage in developing research networks and coalitions.
- Inform practitioners, policymakers, and epistemic communities (researchers and academia) through diverse forms of communication and disseminate the knowledge generated through research and policy analysis.

2. SIAS THEORY OF CHANGE

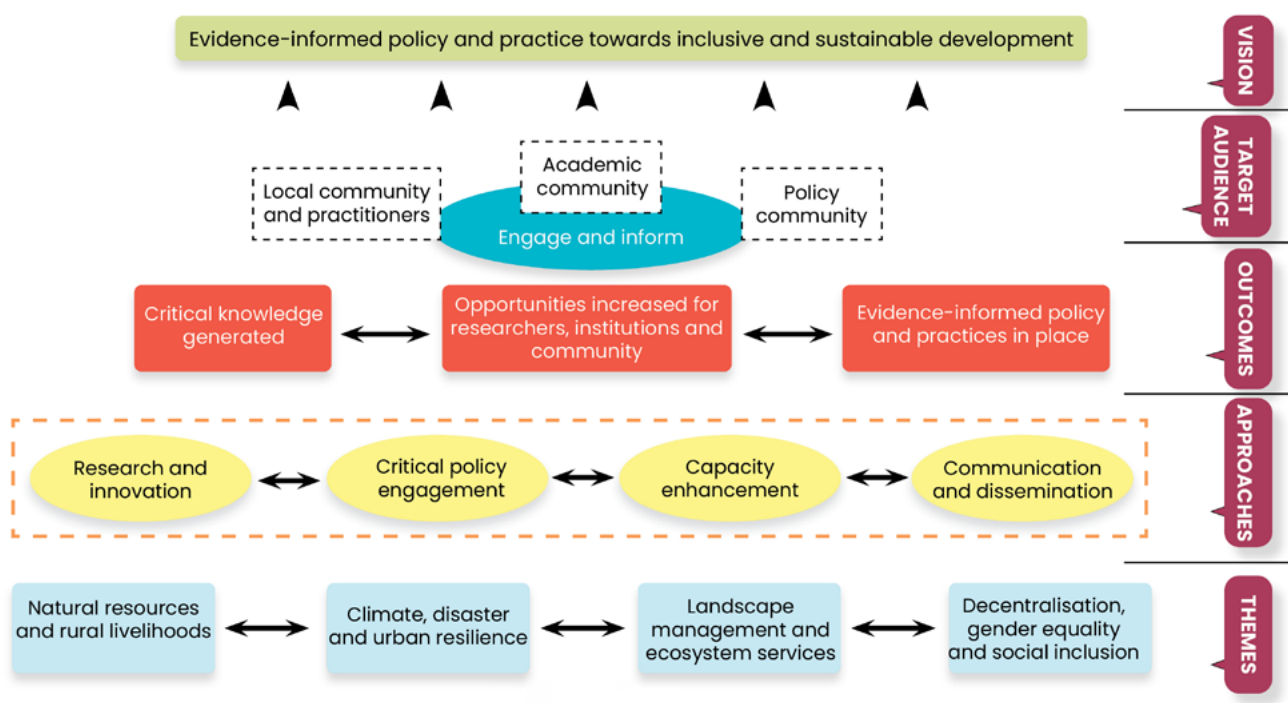
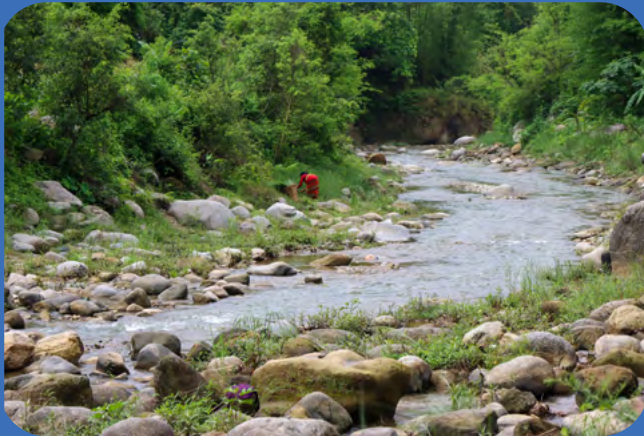


Figure 2: SIAS theory of change

SIAS has adopted the theory of change as its organisational development framework (Figure 2). This framework outlines how SIAS contributes to realising its vision of evidence-informed policy and practice for inclusive and sustainable development. As depicted, SIAS invests in research interventions and policy analysis to achieve desired outcomes, informs its target audience, and works towards its vision. In the light of evolving socio-environmental and national policy contexts and research collaboration opportunities, SIAS has revisited its thematic priorities and identified four central areas: i. Natural resources and rural livelihoods ii. Climate, disaster,

and urban resilience iii. Landscape management and ecosystem services iv. Decentralisation, gender equality and social inclusion (Figure-2 themes). Through these focus areas, SIAS aims to generate critical knowledge and evidence (Figure 2- outcomes) to inform and capacitate policymakers, practitioners, and academic communities (Figure 2- target audience) to foster evidence-informed policy and practices. To achieve this, SIAS adopts four interconnected approaches: research and innovations, critical policy engagement, capacity enhancement (of researchers and stakeholders), and communication and dissemination (Figure 2- approaches).

3. THEMATIC ACHIEVEMENTS



3.1. Natural Resources and Rural Livelihoods

SIAS has been actively promoting inclusive and sustainable approaches to natural resource governance. We have been researching the intricate relationships between natural resources such as forests, land, wildlife and water, with a particular focus on how strengthening the management of these resources contributes to enhance rural livelihoods. Our research at SIAS investigates how shifts in nature-people relationships and the broader political economy of resource

governance affect rural communities and their livelihoods. Under this theme, our work covers subsistence and commercial farming, forest and pasture management, forest landscape restoration, farmers and wildlife interactions, inclusive and sustainable management of springwater sources, and agro-forestry enterprises that support household income, create employment opportunities and contribute to the local and national economy.



Major highlights:

- Through multiple research projects, we have continued to explore resource management within a changing socio-economic context shaped by rural-migration, livelihood transitions and post-COVID-19 recovery in Nepal and the Southasia region.
- Guided by political ecology and intersectional perspectives, our core focus is identifying and addressing barriers to fair and sustainable resource governance, while supporting the [economic empowerment of women](#) and

other marginalised groups.

- We are analysing the emerging challenges, such as intensified [human-wildlife encounters](#), often leading to crop damage and threats to livestock, which further strain smallholder farming systems.
- Bringing these issues into wider policy discussions, SIAS organised various local, and national-level workshops on issues such as institutional functionality of community forest user groups, forest resource governance, wildlife problem and mitigation, and agriculture and forest-based enterprises.

3.2. Climate, Disaster and Urban Resilience

The Himalayan region, with its fragile geology and widespread poverty, is highly vulnerable to climate change and disasters. Rapid and unplanned urban growth, often at the cost of rural and peri-urban areas, along with informal settlements in high-risk zones, has further increased these risks. In this context, SIAS has been actively addressing the linked

challenges of climate change and urban resilience through research and policy engagement. Our work focuses on generating evidence to inform policies and practices related to climate-induced disasters, climate finance, migration, and urbanisation—issues that directly impact people's lives and livelihoods.



Major highlights:

- We are part of a long-term research project that focuses on [migration](#) as an adaptation strategy to climate change. In doing so, we have advanced this discourse by moving beyond simplistic explanations of migration and by unpacking its complex dynamics.
- SIAS has also adopted an interdisciplinary approach and mixed methodologies that integrate survey data, qualitative narratives, and contextual analysis to generate deeper insights for addressing climate and disaster issues.
- SIAS carried out a multi-scalar study on barriers to localising climate finance in Nepal. Analysing across federal, provincial, and local levels, the research identified key challenges such as misaligned government priorities, limited capacity, and governance gaps that hinder effective and equitable climate finance delivery.
- Our research also focuses on water governance in the context of growing urbanisation, climate change, local water politics and increasing conflicts and contestations in relation to accessing water as well as justice and equity concerns.
- SIAS also convened policy dialogues with policymakers, researchers, and civil society, to draw attention to the importance of accountability, coordination, and accessibility of climate financing as well as to promote disaster-sensitive urban planning and foster safer, more inclusive and equitable cities.

3.3. Landscape Management and Ecosystem Services

Landscape management and the provision of ecosystem services are vital to tackling the growing challenges in the Himalayan region. Restoring degraded landscapes contributes to reviving ecosystem functions, rejuvenating springs and other water sources, reducing water scarcity and water-induced disaster risks, and promoting biodiversity and local livelihood opportunities. SIAS seeks to unpack the interconnected drivers and processes

of watershed degradation while fostering the integration of local and traditional knowledge. By promoting context-specific, science-based, and inclusive approaches, SIAS strives to enhance local capacities in designing, testing, and implementing nature-based solutions that support sustainable environmental management and strengthen food, water, and livelihood security.



Major highlights:

- SIAS continues to work on collaborative research examining how, and under what conditions, past [restoration efforts](#) in community-managed forests have impacts on biodiversity, improved human well-being, and contribution to carbon sequestration.
- Through a mixed-method and comparative research in Nepal and India (Himanchal), we focus on strengthening theoretical understandings of community-based forest management and landscape restoration.
- Highlighting how sustainable community participation and strong local institutions underpin the long-term positive outcomes of restoration initiatives, our study contributes not only to global debates but also to future strategies that can make restoration more inclusive, resilient, and impactful in the face of climate change.
- SIAS has strengthened comparative understanding of ecological challenges by promoting cross-country research across the Himalayan region that has fostered a rich perspective on shared vulnerabilities and unique landscape dynamics.
- We are also exploring how changing springwater availability and use influence water access and local livelihoods in the context of accelerating climate change and other socio-economic changes. By generating evidence on how these hydro-social dynamics can (re)produce inclusion and exclusion and affect livelihoods, SIAS seeks to promote inclusive springwater governance and foster equitable and sustainable livelihood opportunities, particularly for women and marginalised communities.

3.4. Decentralisation, Gender Equality and Social Inclusion

Our research in this area focuses on how local and provincial governments in Nepal are exercising the authority and resources devolved to them, and the challenges they face under the federal governance structure. SIAS contributes to local and national policy processes through rigorous research, evidence-based stakeholder dialogues across all levels of government, and by sharing knowledge from its key thematic areas. Since its establishment, SIAS has prioritised gender equality and social inclusion, working to ensure that marginalised voices are meaningfully represented in natural resource management and climate governance. Across its research, SIAS has



shown how gender and social hierarchies influence access to resources and shape participation in decision-making. By placing women and disadvantaged groups at the centre of its work, SIAS highlights their role as key actors in building resilient, equitable, and prosperous rural futures.

Major highlights:

- Our research has highlighted that while the devolution of resources and authorities has created opportunities for strengthening local governance, it is important to strengthen local governments' overall institutional capabilities, crucial to carry out their entrusted roles effectively.
- Building on research insights, we have conceptualised a framework for women's economic empowerment and inclusive governance at both local and national levels.
- We are assessing key barriers and opportunities faced by women entrepreneurs in accessing finance and ways of improving their financial access.
- SIAS has also been reviewing the federal policies in agriculture, forestry, cooperatives and economic policies from gender and social inclusion and

women's economic empowerment focus to understand the policy implementation challenges, the policy-practice gaps, and issues related to sectoral coherence, that enable or constrain women's empowerment in these sectors.

- At the local level, SIAS has supported municipalities in adopting Gender Responsive Budgeting (GRB) as a tool to integrate gender perspectives into planning and financial decision-making.
- By establishing peer-learning platforms, SIAS created spaces where multiple municipalities could share experiences, challenges, and innovations, fostering cross-learning on how GRB can be effectively embedded in local governance systems. These efforts not only promote gender-sensitive budgeting practices but also strengthen institutional accountability and inclusiveness in local development processes.

4.1. ACADEMIC AND POLICY-RELEVANT PUBLICATIONS



SIAS researchers have actively shared their work in leading national and international journals, contributing to both academic debates and policy discussions. In 2024–2025, SIAS researchers have published four articles in internationally peer-reviewed journals. Similarly, five articles have been published in a special issue of *New Angle: Nepal Journal*

of *Social Science and Public Policy*, an internationally peer-reviewed journal article published annually by SIAS. The title of this issue this year was [“Women’s Empowerment in Natural Resources Management in the Himalayas” \(Vol. 9, No. 1\)](#).

Our team also published a policy brief exploring the intersection of digital technology and the agriculture sector, highlighting how digital tools are transforming farming



practices while creating both opportunities and challenges for women farmers. In addition, an introductory booklet on the sustainable management of wintergreen (in Nepali), aimed at sharing knowledge on sustainable practices and various processes of wintergreen distillation with CFUG representatives and other stakeholders. Our peer-reviewed publications further emphasised the vital role of agricultural cooperatives in promoting commercialisation and women’s empowerment, advancing gender-responsive budgeting at the local level for inclusive planning, and improving women’s access to financial credit.

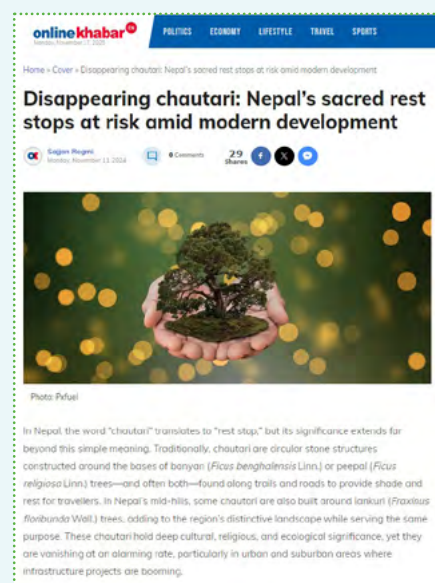
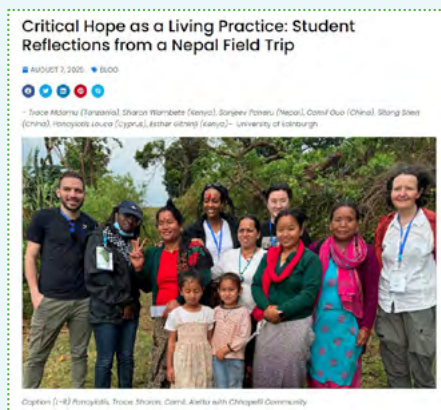


4.2. MEDIA COVERAGE

In this period, SIAS has continued to make significant contributions to national and international discourse through research, publications, and media engagement. Its activities and events have been widely covered in national newspapers and online news portals, enhancing visibility and outreach. During this period, SIAS researchers have published twelve blogs/ OPED, 10 in English and 2 in Nepali, covering a diverse range of topics including gender equality, fiscal decentralisation, engineered disaster, conservation justice, and insights from field experiences in Nepal. These offer insights into diverse natural resource governance,

livelihoods and disaster related issues reflecting the intersection of environmental and social dimensions in SIAS's research.

SIAS research and perspectives have also gained prominence through mainstream media and academic platforms, including the YouTube feature Diktel: The Story of Water in the Mountains (in English and Nepali), which highlighted community experiences in water management and was featured in Diktel Water Forum. Collectively, these outputs illustrate SIAS's commitment to knowledge co-creation, dissemination, and policy dialogue, demonstrating how research can engage diverse audiences, inform decision-making, and foster inclusive and resilient development practices.



4.3. NATIONAL, REGIONAL, AND INTERNATIONAL OUTREACH AND ENGAGEMENTS



This year, SIAS further strengthened its national, regional, and international presence by organising and participating in national and international workshops, dialogues, symposiums, and academic forums. At the national level, SIAS co-organised a symposium on women's economic empowerment through natural resources, bringing together multiple stakeholders to identify challenges, share good practices and innovations, and develop approaches that inform policymakers and other key actors. Similarly, the dialogue on climate change and migration convened researchers and practitioners from Nepal and abroad, providing a platform to critically reflect on the complex links between climate and migration and to explore potential pathways for research and policy. Additionally, as a part of our collaborative research on springwater governance, SIAS researchers worked closely with interdisciplinary team of researchers from Nepal and Australia as well as local and federal representatives. Collectively, these initiatives demonstrate the expanding network of SIAS through its research-based commitment to fostering inclusive, evidence-based dialogues on issues of critical importance to Nepal.

At the regional and international levels,

SIAS researchers represented the institute in a wide range of forums, participating as panellists, presenters, and contributors to key discussions. They engaged in global debates on inclusive climate change adaptation governance, water policy, urban resilience, and disaster risk reduction, while also contributing to critical conversations on climate justice, migration, and the challenges of precarious water futures beyond South Asia. These engagements have not only facilitated knowledge exchange but also positioned SIAS as a prominent research institution from Nepal and the broader South Asian region in international forums. Through these, SIAS has strengthened collaborations with global peers, and expanded its networks. These international contributions underscore SIAS's commitment to connecting local and regional experiences with global debates.

4.4. CAPACITY BUILDING

SIAS has continued to strengthen research and writing capacities through a series of workshops, writeshops, and research club activities. These initiatives provided a platform for researchers, collaborators, and students to enhance their academic writing, analytical, and presentation skills while engaging with peers in constructive dialogue.

SIAS organised and co-hosted several writing workshops to promote collaborative academic writing. The Uncertainties Network Writing Workshop brought together partners from Nepal, India, Bhutan, and Sweden to write draft book chapters on uncertainties in mountain ecosystems. In addition, SIAS researchers held project-based writing sessions to draft papers, provide feedback, and refine publications. These workshops created space to work on journal articles, review data, and strengthen the thematic focus of ongoing publications.

Senior researchers and experts at SIAS continue to strengthen the research capacity of emerging scholars. During this period, Dr. Govinda Paudel led a session on effective note-taking, Dr. Sony Baral facilitated a discussion on Systematic Literature Review, and Dr. Adam Pain conducted a seminar on critical reading. These sessions collectively enhanced participants' methodological understanding, analytical skills, and academic writing, fostering their ability to

conduct rigorous and robust research.

The SIAS research club, which started two years ago to support young researchers within and outside SIAS, continued this year as well. Two sessions were organised during this period. In one seminar, a Master's student from Swedish University of Agricultural Sciences (SLU shared her thesis findings on social equity and climate adaptation in Nepal's mid-hills). The other session focused on practical orientations on Microsoft Word and Excel, led by the SIAS Admin team.

SIAS organised a two-week field course for Master's students from the University of Edinburgh, UK. Facilitated by experts in natural resource management, the course included field visits outside the Kathmandu valley where students interacted with local communities and discussed human-wildlife encounter. These engagements offered insights into Nepal's environmental and development challenges. Based on their experiences, the participating faculty and



5. ORGANISATIONAL DEVELOPMENT





5.1. Institution building

During this period, SIAS undertook several initiatives on organisational development towards further strengthening its reputation as a leading think tank. Building on its strategic direction, SIAS has revised its thematic priorities and designated thematic leaders in forest, water, urban and disaster and climate change. These thematic leaders are playing a key role in driving research agendas, expanding institutional networks, and engaging in policy processes through organising or contributing to policy dialogues, symposiums, workshops, and other knowledge-sharing platforms.

SIAS has continued expanding its network and fostering partnerships across international, regional, and local levels. A notable step in this direction was the organisation's application for accreditation with the United Nations Framework Convention on Climate Change (UNFCCC), positioning SIAS to engage in the Conference of the Parties (CoP) in the future. In addition, SIAS has also initiated new research collaborations during this period, which include the new research with the Commonwealth Scientific and Industrial Research Organisation (CSIRO)/ the Australian Centre for International Agricultural Research (ACIAR), the University of Dublin, and the University of Gothenburg

SIAS has placed a strong emphasis on research outreach and increasing its visibility through consistent updates to its website and active engagement on social media platforms. In doing so, we have prioritised translating the knowledge generated by researchers into local and vernacular languages and distilling key findings into accessible formats for diverse audiences.

Furthermore, SIAS researchers have remained committed to upholding and reflecting on institutional policies and ethical standards through regular internal discussions and reviews of the organisation's ethical guidelines, publication and authorship policies, Gender Equality and Social Inclusion (GESI) policy, and administrative and financial protocols across both research and operational activities.

SIAS is also striving to build its multi-disciplinary team of researchers and develop capacity on some aspects where we are relatively weak. In this process, we are committed to strengthen our quantitative skills and team. We have carried out a major quantitative survey and are collaborating with researchers with expertise in quantitative research. In parallel, SIAS has invested in team-building activities such as retreats and refreshment events, while senior researchers



have actively mentored emerging scholars through collaborative writing, publication efforts, and capacity development programs.

SIAS remains committed to fostering gender and social diversity within its workforce, actively promoting gender-balanced and socially inclusive approaches both in the office and in field-based activities. To ensure transparency, accountability, and institutional learning, SIAS continued its practice of systematically documenting achievements and lessons through the publication of its annual report and quarterly newsletters. Furthermore, the annual staff performance evaluation process has encouraged individual reflection on yearly achievements and facilitated the setting of future goals, including publication targets, participation in national and international forums, and alignment with the organisation's core values.

Furthermore, SIAS has continued its flagship events such as deliberative forums and Future Himalaya Research Seminar Series, continuing to provide platforms for deliberation among different stakeholders and the academic community, respectively.

SIAS has also undertaken a strategic review of the *New Angle* journal, revising its scope and guidelines. As part of this effort, discussions are underway to expand the journal's reach to a regional audience and to introduce a general issue starting from Volume 11, marking a shift from its previous focus solely on thematic special issues.

5.2. Partnership and funding diversity

SIAS has continued to strengthen its collaborations with existing partners while actively expanding its networks by pursuing new research grants in cooperation with both long-standing and emerging national, regional, and international partners. Despite the increasing challenges of securing competitive research funding, SIAS has successfully obtained highly competitive grants. This expertise has enabled SIAS to establish stronger connections with diverse stakeholders in natural resource management, including those working in land, water, forestry, and agriculture. Through multidisciplinary action research initiatives such as the "Climate and Migration" and improved and inclusive springwater governance, SIAS has actively fostered collaborations that bring together physical and social scientists worldwide to address complex socio-environmental challenges. These efforts not only strengthen interdisciplinary approaches but also open new pathways for innovation and impact. Further, SIAS has expanded its partnership at the local and national level with different local governments, research, and other institutions. A detailed list of SIAS's partners and collaborators is provided in Annex 7.

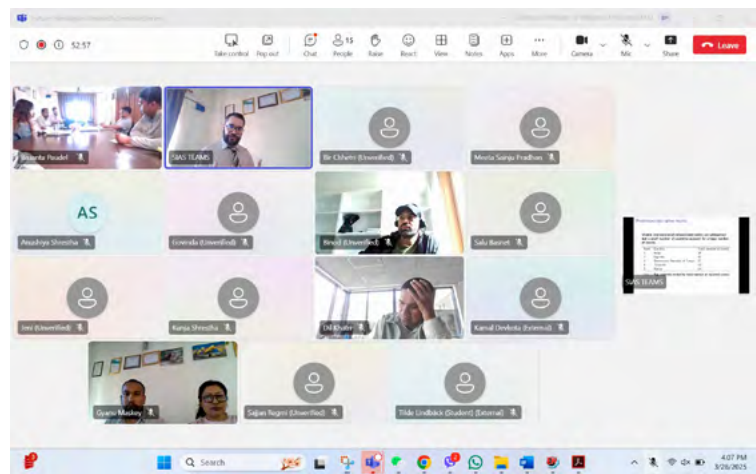
6. OTHER INITIATIVES



6.1. Future Himalayan Research Seminar

The Future Himalayan Research Seminar (FHRS) is a flagship initiative of SIAS designed to promote a culture of scholarly exchange and collective learning. It serves as a platform for both national and international researchers and experts to present their work, share experiences, and engage in meaningful dialogue. Each year, SIAS invites leading experts to contribute to strengthening critical analytical skills and advancing knowledge development. Beyond research presentations and feedback, the seminar also fosters social and intellectual connections among peers and experts from diverse research traditions, all within the broader thematic focus of the seminar.

During this period, SIAS organised five seminars featuring presentations by its researchers, international scholars, and visiting practitioners. Conducted in a hybrid format, the seminars allowed both in-person and online participation. The topics of the seminar covered a wide range of critical issues, including violent events linked to environmental enforcement, locally grounded understandings of climate change that integrate community knowledge, the multifaceted concept of care and others. Details of the seminars have been listed in Annex 3. Each session included interactive discussions, fostering experiential learning and collaborative knowledge exchange. FHRS has reinforced SIAS's commitment to fostering meaningful spaces for dialogue, reflection, and interdisciplinary learning.
